Finance Committee Meeting 6 May 2021 2:30 PM

#### **Opening Meeting**

- I. Jennifer Burnett called the meeting to order and welcomed everyone. She noted that we did not have 3 committee members present, so no votes would be taken.
- II. Following the agenda, then turned the meeting over to Jonathan Martin, the CFO for the VMNH.

### **Budget Summary -**

III. Jonathan reviewed the recently approved budget highlighting that Fiscal Year 21 and Fiscal Year 22 were identical. Also, he was happy to report all positions were funded and the budget also restored our operations and maintenance funding. He proceeded to note new spending initiatives that include but are not limited to an across-the-board raise for all state employees and some potential new hires coming in FY22.

#### **Q3 Balance Sheet Review -**

- IV. Next, the committee reviewed the balance sheet for the third quarter of FY21. Revenues looked good with an optimistic attitude toward future earnings. Expenses were mostly in line with estimates from the beginning of FY21. The major increase was seen in subscriptions due to the new demands for telecommuting and zoom conferences. Jonathan went on to note that adjustments will be made to account for these new expenses in the FY22 budget.
  - A. Roberto noted that all looked in line with revenue estimates for FY21.
